### ISO 14001

ISO 14001 is an international standard for Environmental Management Systems (EMS). It helps organizations improve environmental performance, ensure regulatory compliance and promote sustainable practices



### ISO 9001

ISO 9001 is an international standard for Quality Management Systems (QMS). It focuses on consistent product quality, customer satisfaction, and continuous improvement.



### ISO 50001

## 03 PILOT CERTIFICATE

A Pilot Certificate for drones is an official authorization required for individuals operating drones in regulated airspace or commercial activities. It confirms that the drone pilot has completed the necessary training and understands aviation safety and operational guidelines. This certificate is essential for legal drone operations and helps ensure safe, compliant, and responsible use of drones in India.



## 04 UNIQUE IDENTIFICATION NUMBER

A Unique Identification Number (UIN) for drones is an official registration number issued by the aviation authority to identify and track drones operating in India. It is mandatory for eligible drones and helps ensure legal operation, safety compliance, and proper monitoring. The UIN links the drone to its owner and is required for regulatory approvals and authorized drone activities.

## One Person Company (OPC) Registration

## LLP Registration

Limited Liability Partnership (LLP) Registration is governed under the LLP Act, 2008 and allows partners to operate with limited liability protection and flexible management structure. It requires a minimum of two partners.

04



## Firm Registration

Firm Registration is governed under the Indian Partnership Act, 1932 and allows two or more individuals to carry on business together with shared profits and responsibilities.

05



## Startup India Registration

Startup India Registration provides recognition to eligible startups under the Government of India initiative, offering tax benefits, funding support, and regulatory relaxations.



06



### GeM Registration

GeM Registration enables businesses to list and sell products or services on the Government e-Marketplace (GeM) portal for procurement by Government departments and public sector units.

07



### Private Limited Company Registration

Private Limited Company Registration is governed under the Companies Act, 2013 and allows a business to operate as a separate legal entity with limited liability. It requires a minimum of 2 directors and 2 shareholders.

### Indian Subsidiary Company Registration

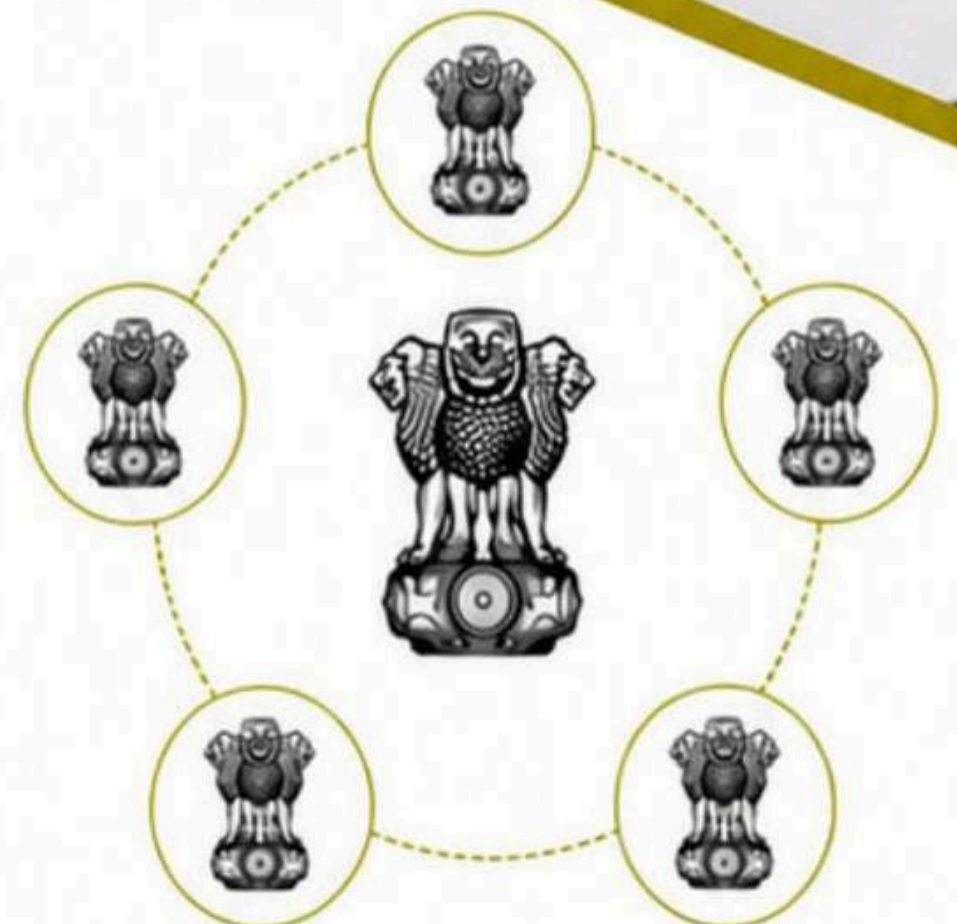
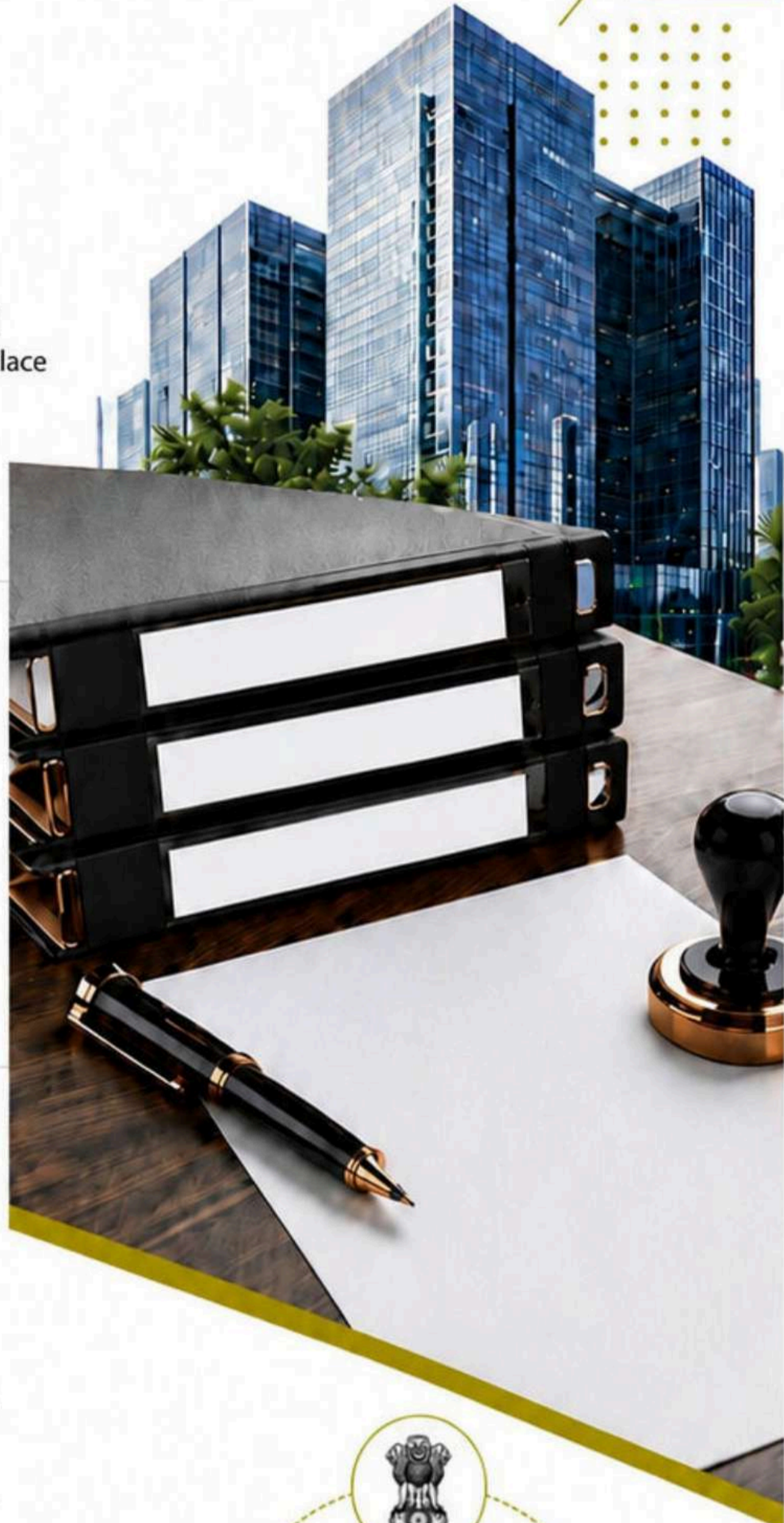
Indian Subsidiary Company Registration allows a foreign company to establish a legally recognized entity in India under the Companies Act, 2013, with limited liability and compliance requirements.

### Producer Company Registration

Producer Company Registration is governed under the Companies Act, 2013 and is formed by farmers or producers to collectively engage in production, harvesting, procurement, grading, and marketing activities.

### Sole Proprietorship Registration

Sole Proprietorship Registration allows an individual to operate and control a business independently. The owner holds full control and unlimited liability for business operations.

### Partnership Firm Registration

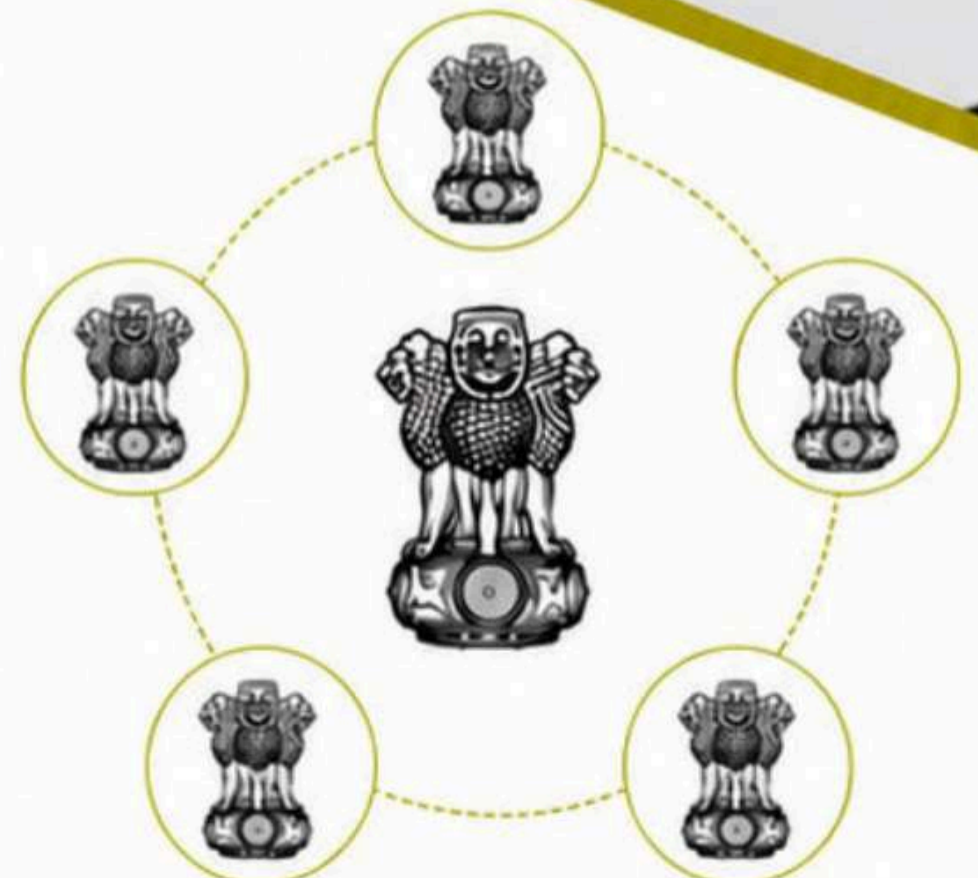
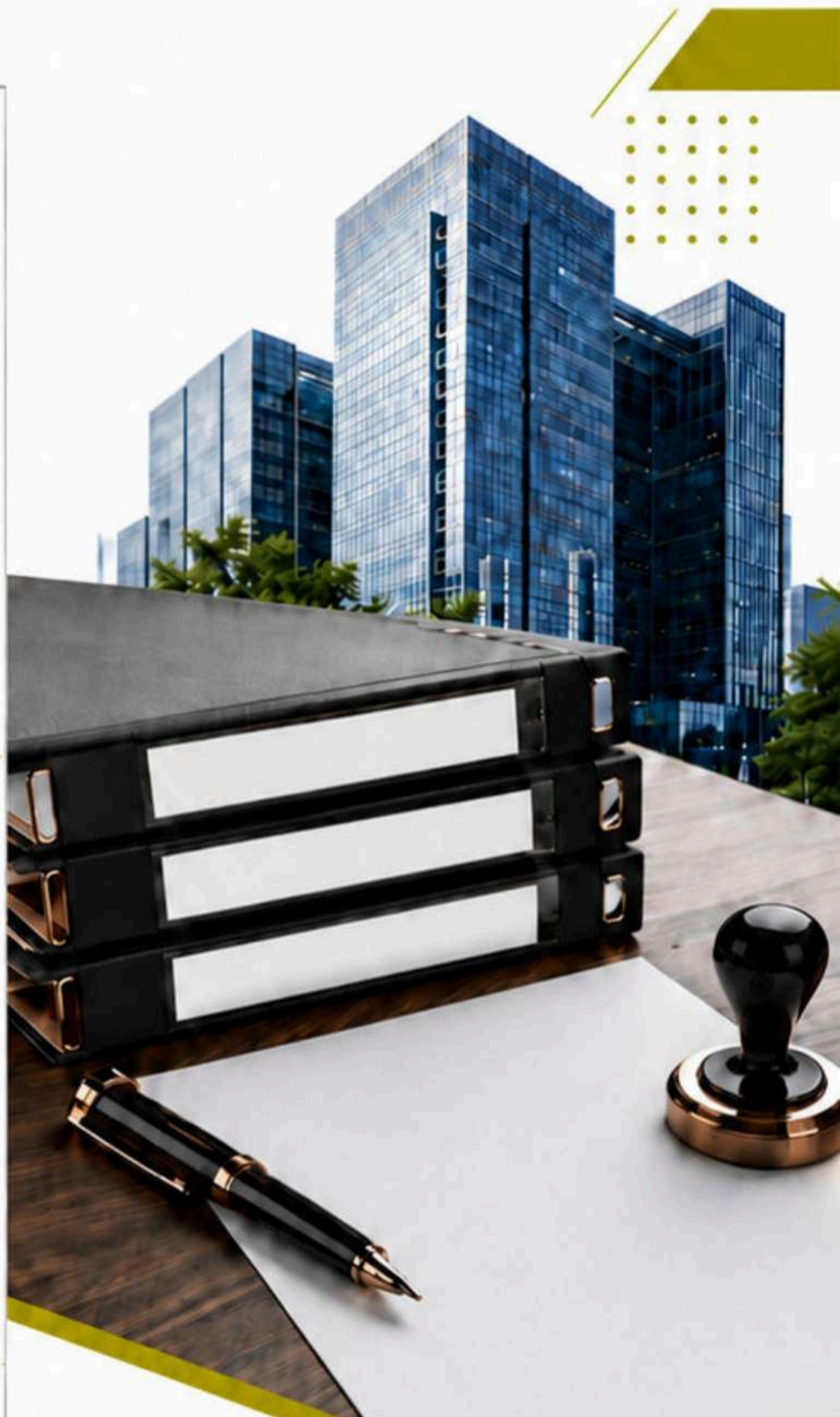

# LEGAL NOTICE

01

## Legal Notice



A Legal Notice is a formal written communication sent to an individual or entity regarding a dispute or legal claim. It serves as a final opportunity to resolve the matter before initiating court proceedings.

02

## RERA Compliance



RERA Compliance ensures real estate projects follow the Real Estate (Regulation and Development) Act, 2016. It mandates proper registration, disclosures, and protection of homebuyer rights.

03

## Public Interest Litigation (PIL)



Public Interest Litigation allows any individual or organization to approach the court for matters affecting public interest. It aims to protect fundamental rights and promote social justice.

04

## Caveat Petition



A Caveat Petition is filed to ensure that no court order is passed without prior notice to the Caveator. It safeguards the right to be heard before any interim decision.

05

## Legal Heir Certificate



Legal Heir Certificate identifies the rightful heirs of a deceased person. It is required for claiming property, insurance, pension, or other financial benefits.

06

## Section 8 Demand Notice



Section 8 Demand Notice is issued under the Insolvency and Bankruptcy Code, 2016 for recovery of operational dues. It provides the debtor 10 days to clear outstanding payments.



07



### Succession Certificate

Succession Certificate is granted by a civil court to legal heirs. It authorizes them to claim debts, securities, and financial assets of the deceased.

08



### Lease Agreement Drafting

Lease Agreement Drafting is the process of preparing a legal rental document between landlord and tenant. It clearly defines rent, tenure, security deposit, responsibilities, and terms.

09



### Will Drafting

Will Drafting is the process of legally declaring how a person's assets will be distributed after death. It ensures smooth transfer of property to beneficiaries.

10



### Mutual Divorce

Mutual Divorce is a legal process where both spouses consent to dissolve the marriage amicably. It simplifies proceedings and settles issues like alimony and custody.

11



### Property Registration

Property Registration legally records the transfer of ownership with the sub-registrar office. It provides lawful recognition and protection of ownership rights.

12



### Divorce Notice

Divorce Notice is a formal legal communication sent by one spouse to initiate divorce proceedings. It outlines the intention and grounds for dissolution of marriage.

13



### Property Valuation

Property Valuation determines the fair market value of real estate. It is essential for sale, taxation, loan, or legal purposes.



14



### Lease Registration

Lease Registration records a lease agreement with the appropriate authority. It ensures legal validity and enforceability of tenancy rights.

15



### Property Verification

Property Verification involves checking title documents, ownership history, and encumbrances. It ensures the property is legally clear before purchase.

16



### Hindu Marriage Act

The Hindu Marriage Act, 1955 governs marriage, divorce, and related rights among Hindus in India. It outlines legal provisions for matrimonial remedies and obligations.

17



### Divorce Settlement Agreement

Divorce Settlement Agreement defines mutually agreed terms between spouses. It covers alimony, child custody, asset division, and financial arrangements.

18



### Domestic Violence

Domestic Violence in India includes physical, emotional, sexual, verbal, and financial abuse. The Domestic Violence Act, 2005 protects women and provides legal remedies like protection orders, monetary relief, and police complaints.

19



### Bail Application

Bail Application is filed before a court seeking temporary release of an accused. It ensures liberty while trial proceedings continue.

20



### Judicial Separation

Judicial Separation is a court order allowing Spouses to live separately without ending the marriage. It provides legal recognition of separation.



21



### Will Registration

Will Registration involves officially recording a will with the sub-registrar. Though optional, it strengthens authenticity and reduces disputes.

22



### Special Leave Petition (SLP)

Special Leave Petition is filed before the Supreme Court under Article 136 of the Constitution. It challenges judgments passed by lower courts or tribunals.

23



### Consulting Agreement

Consulting Agreement sets out the terms between a consultant and client. It defines scope of work, payment terms, confidentiality and responsibilities

24



### Vendor Agreement

Vendor Agreement outlines terms between a supplier and purchaser for goods or services. It specifies pricing, delivery, payment, and dispute resolution terms..

25



### License Agreement

License Agreement grants permission to use intellectual property, brand, or assets under defined conditions. It specifies rights, limitations, and duration

26



### Tenant Eviction

Tenant Eviction is a legal process to remove a tenant due to non-payment or breach of agreement. It must follow applicable rent control and property laws.

# TRADEMARK REGISTRATION

**01****Trademark  
Registration**

Trademark Registration provides legal protection to a brand name, logo, symbol, or tagline under the Trade Marks Act, 1999. It grants exclusive rights to use the mark and prevents unauthorized usage by others.

**02****Trademark  
Objection**

Trademark Objection is raised by the Trademark Examiner during the examination process if any discrepancies or conflicts are found. A proper legal reply must be filed to justify and defend the application

**03****Trademark  
Assignment**

Trademark Assignment refers to the transfer of ownership rights of a registered or pending trademark from one party to another. It can be done with or without goodwill as per agreed terms.

**04****Trademark  
Rectification**

Trademark Rectification is the process of correcting or removing an incorrect entry from the Trademark Register. It may be filed in case of errors, wrongful registration, or non-use of a trademark.



## 05 | Trademark Renewal

Trademark Renewal extends the validity of a registered trademark beyond its initial 10-year period. It ensures continued legal protection and exclusive rights over the mark.

## 06 | Trademark Licensing

Trademark Licensing allows the trademark owner to grant permission to another party to use the mark under specified terms. It helps in brand expansion while retaining ownership rights.

## 07 | Trademark Opposition

Trademark Opposition is a legal objection filed against the registration of a published trademark. It can be initiated by any third party within the prescribed time period.



# COPYRIGHT REGISTRATION



## Copyright Registration

Copyright Registration provides legal protection to original literary, artistic, musical, cinematographic, and software works under the Copyright Act, 1957. It establishes ownership and grants exclusive rights to reproduce, publish, and distribute the work.



## Copyright Disclaimer

Copyright Disclaimer is a legal statement specifying ownership rights and limiting unauthorized use of content. It helps clarify permissions, restrictions, and liability related to copyrighted material.



## Copyright Licensing

Copyright Licensing allows the copyright owner to grant permission to another party to use the work under agreed terms. It defines scope, duration, territory, and royalty conditions.



## Copyright Objection

Copyright Objection may be raised during the registration process if discrepancies or claims arise. A formal response or clarification must be submitted to proceed with registration.



## Copyright Assignment

Copyright Assignment is the legal transfer of ownership rights from the creator to another party. It must be executed through a written agreement specifying rights and duration.



# PATENT REGISTRATION



## Patent Registration

Patent Registration grants exclusive rights to an inventor for a new and inventive product or process under the Patents Act, 1970. It prevents others from making, using, or selling the invention without permission.



## Indian Patent Search

Indian Patent Search involves examining existing patents and publications to determine novelty and avoid infringement. It helps assess the patentability of an invention before filing.



## Patent Opposition

Patent Opposition allows third parties to challenge the grant of a patent on specific legal grounds. It can be filed before or after the patent is granted.



## Patent Revocation

Patent Revocation is the legal cancellation of a granted patent by the court or patent authority. It may occur due to lack of novelty, wrongful grant, or non-compliance with legal requirements.

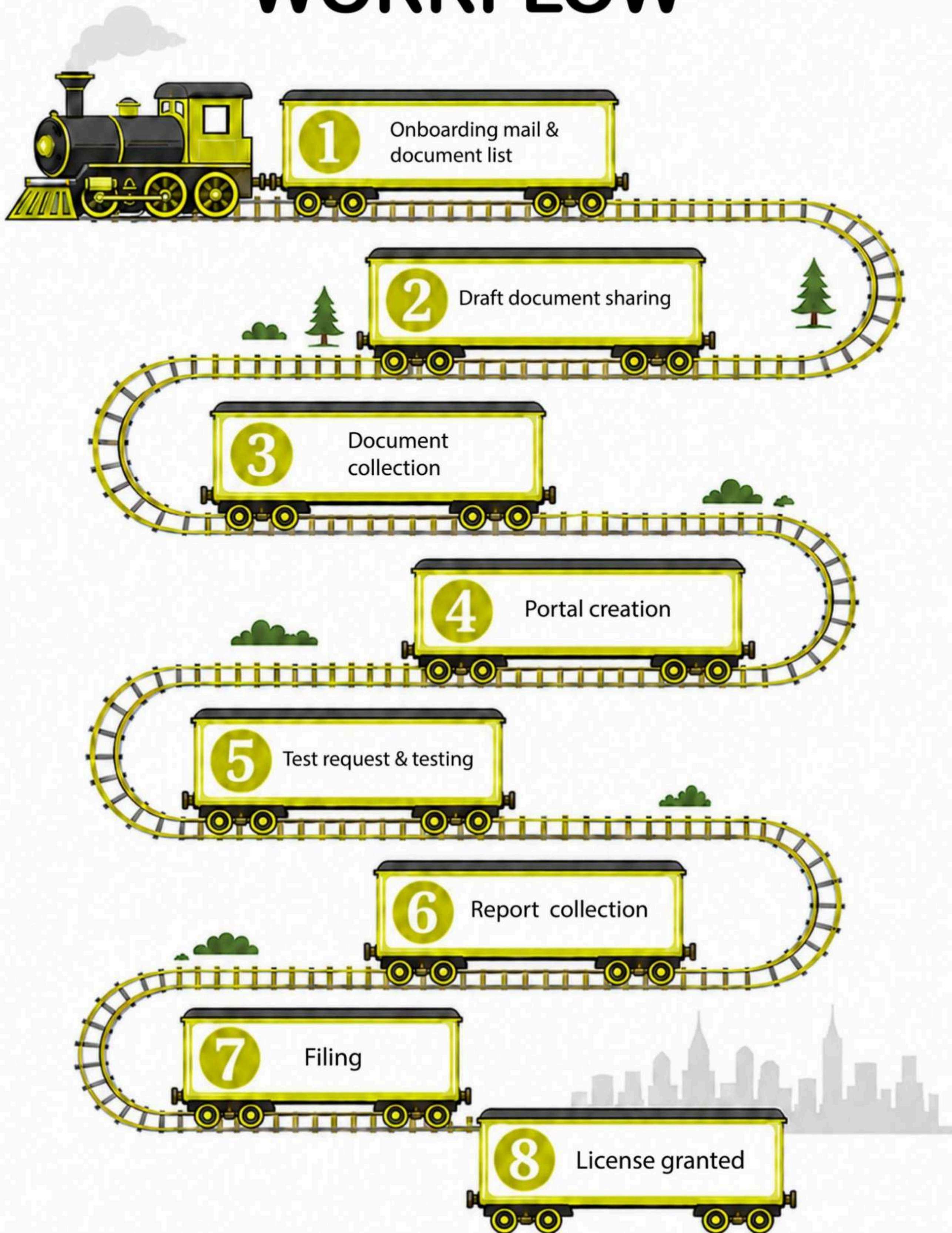
